HOFBURG briefly delayed the start reluctant to load, came away in good order only to be strung out five wide around the first turn, moved after the leaders four wide into the far turn, took over from TRAVELLING MIDAS as they shifted nearer the inside with a quarter-mile remaining, drifted out in deep stretch while clear, and straightened out in time to keep JUST WHISTLE at bay. JUST WHISTLE was four wide around the first turn, moved past rivals three wide around the far turn, rallied outside HOFBURG and was floated out a bit past the sixteenth-pole, and could not get by. TRAVELLING MIDAS pressed the pace three wide, rallied to the lead shifting to the two-path past the three-eighths, could not match strides with HOFBURG turning for home, and saved the show while tiring late. PERSONAL TIME broke slowly and was far back inside for six furlongs, angled wide off the far turn and passed tired horses outside. B I MOODY dueled for command outside COUNTRY SQUIRE, and began to fade around the far turn. NUMERO THIRTEEN bumped with HONIG heading into the first turn, moved inside through the middle stages, came three wide to the lane and posed no threat. ECLIPSED MOON was slow into stride, angled widest for the stretch run and was never a factor. C C RIDER was bothered by COUNTRY SQUIRE after the start, stayed close behind the leaders inside for a half-mile, and tired after six furlongs. RARE FORM raced in range between horses two wide to the far turn, and had nothing left. COUNTRY SQUIRE stumbled at the start and broke out into the path of C C RIDER, recovered to duel for the lead inside B I MOODY, and gave way before completing six furlongs. HONIG bumped with NUMERO THIRTEEN heading into the first turn, raced in the second flight and dropped back after a half-mile. A CLAIM OF FOUL BY THE RIDER OF JUST WHISTLE AGAINST THE WINNER WAS NOT ALLOWED.
