DADDY NOSE BEST was allowed to settle early, rallied between splitting foes in the second turn, angled three wide in the stretch, was roused nearing the sixteenth pole, responded and inched away. ISN'T HE CLEVER stalked the early leaders four wide, closed the gap down the backstretch, rallied to gain the lead drawing clear, held to deep stretch, was challenged by DADDY NOSE BEST, failed to match strides and was outfinished. STIRRED UP prompted the early pace four wide, lost ground into the stretch, then came back with some effort late to gain the show. NO SPIN was unhurried early racing five wide, drifted in three wide in the stretch and lacked a gain late. ENDER KNieVEL pressed the early pace from the outside, dueled briefly then gave way. TEQUILA FACTOR was off slow early, went five wide and passed a tiring foe. CASTAWAY set a pressured early pace, dueled briefly along the rail and was finished early. JUSTANOLDSONG dropped back, saved ground throughout and was eased to the wire.
